TREEDC FOUNDING MEMBER GIBSON COUNTY UTILITY DISTRICT BREAKS GROUND ON ENERGY COMPLEX

On September 23, 2014, the Gibson County Utility District (GCUD) Board of Commissioners broke ground on the Gibson County Energy Complex. The \$1.5 million natural gas fueling station is located at the corner of North College Street and the Highway 45W Bypass in Trenton, adjacent to the Utility District home office.

“Today Gibson County Utility District takes a visionary leap into America’s transportation history with an eye on sustainability and the environment with the construction of the greenest natural gas refueling station in Tennessee,” said Pat Riley, TREEDC Board Member/ GCUD General Manager. “Today we break ground for the economic future and well being for the people of Trenton and Gibson County, regionally for West Tennessee, and America.”

The Gibson County Utility District has committed to converting its entire fleet to NGVs in the next five years, and Riley proudly drives his NGV pickup truck all over the county and state to promote the energy source that could drastically reduce America’s dependence on foreign oil.

To build the Gibson County Energy Complex, the first natural gas station between Memphis and Nashville, Riley and the GCUD Board of Commissioners sought advice from the brightest minds in the business and formed relationships with state environmental leaders to create a model for the state and entire nation. A natural gas generator will provide power for the station, and two 50-ft. banks of solar panels (made in America) will provide lighting. Crews will install an electric grid that should be the final backup, which means on a typical day, the station will leave a carbon footprint of zero. The district will also utilize pervious concrete, which traps 50 percent of moisture to retain storm water runoff. Congratulations to GCUD!


PATHWAY LENDING AWARDED \$1.75 MILLION TO EXPAND SUPPORT OF

The U.S. Department of Treasury’s Community Development Financial Institutions Fund awarded \$195.4 million to CDFIs across the country to increase their lending and investments in low-income and economically distressed communities. Pathway Lending is among just 38 business loan funds to be awarded in the FY 2014 round, and is the only recipient in the State of Tennessee. These grants invest in and build the capacity of CDFIs, like Pathway Lending, empowering them to grow, achieve organizational sustainability, and contribute to the revitalization of their communities. The funds will enable Pathway Lending to expand its capacity to provide affordable financial products and services to small and growing businesses in Tennessee.


