TREEDC Holds 6th Annual Conference at Tennessee Tech University

The Tennessee Renewable Energy & Economic Development Council (TREEDC) recently held its 6th annual Renewable Energy Conference at TREEDC Founding Member Tennessee Tech University on December 12 – 13, 2019. The theme of the conference was "Creating a Renewable Energy and Economic Development Toolbox for Local Governments". It brought together leadership from The University of Tennessee (UT) Municipal Technical Advisory Service (MTAS), United States Department of Agriculture (USDA) Rural Development, UT-Martin, Tennessee Tech University, Tennessee Valley Authority (TVA), the State Department of Environment and Conservation (TDEC) Offices of Energy Programs and Tennessee Department of Economic and Community Development (ECD) Rural Development. Mayors and officials representing the cities of Chattanooga, Franklin, Knoxville and McKenzie discussed their best practices in economic development and renewable energy. Various technologies presented included solar, waste to energy, energy efficiency, compressed natural gas and wireless street lighting. TREEDC awards were given to statewide leaders in renewable energy in 2019.

The University of Tennessee at Martin Chancellor/TREEDC Chairman Keith Carver welcomed the audience. Keynote addresses were presented by Johnson Controls Business Development Director Brandie Williams regarding the future of renewable energy related batteries and Tiffany Wilmot highlighting a viable community toolbox for sustainability and economic development. 2019 TREEDC Champion awards were granted to Chattanooga Mayor Andy Berke and Brian Stone of NORESCO. Mayor Berke has helped catapult Chattanooga in excellence in sustainability with the solar share program, building better cities initiatives and creating a resiliency task force for Chattanooga area mayors. Stone developed and managed the Dunlap Energy Efficiency Project. This project upgraded 130 city streetlights to LED bulbs, installed high-efficiency LED interior and exterior lights at all city buildings, water meters, and installed solar arrays on the roofs of nine municipal buildings including city hall, the fire department, police department, a city park, town maintenance facility, water treatment plant, and wastewater treatment plant.

Knoxville Mayor Madeline Rogero was granted "TREEDC Mayor Emeritus" for her outstanding contributions to clean energy and TREEDC over the past eight (8) years. TREEDC Community Leadership Awards were granted to Bolivar Mayor Julian McTizic, Cookeville Mayor Ricky Shelton and Livingston Mayor Curtis Hayes. TREEDC Legislator awards were granted to Senator Frank Nicely and Representative Kelly Keisling. ACS Commercial Roofing was recognized as a 2019 TREEDC Business Champion. ACS was recognized for their exemplary services to Metro Nashville Public Schools. Knoxville Receives Recognition for Propane Mower Fleet

The Propane Education and Research Council (PERC) recently honored the City of Knoxville with its 2019 Green Leadership City Award, which PERC provides to one American city each year in recognition of said community's commitment to social and environmental health. PERC recognized Knoxville for its adoption of a clean, propane-powered mower fleet as well as other environmentally friendly programs that support the City's sustainability and emissions-reductions goals. By September 2019, the City had converted 18 of its 25 commercial lawnmowers to run on propane, reducing the mowers' carbon dioxide emissions by 10 tons in 2018 alone. During the award ceremony, Knoxville Mayor Madeline Rogero accepted a \$5,000 donation from PERC, which will go toward the Beardsley Community Farm, a Knoxville-Knox County Community Action Committee nonprofit that promotes food security and sustainable agriculture.

Tennessee Clean Fuels Turns 15

U.S. DOE's Clean Cities program advances the nation's economic, environmental, and energy security by working locally to advance affordable, domestic transportation fuels and technologies. In Tennessee, there are two U.S. DOE-designated Clean Cities Coalitions: the Middle-West Tennessee Clean Fuels Coalition (MWTCF) and the East Tennessee Clean Fuels Coalition (ETCF). Collectively, these Coalitions are known as <u>Tennessee Clean Fuels</u>.

This October, both MWTCF and ETCF celebrated their 15th anniversaries as Clean Cities Coalitions under U.S. DOE. Since inception in 2004, the two coalitions have brought together stakeholders in the public and private sectors to deploy alternative and renewable fuels, idle-reduction measures, fuel economy improvements, and new transportation technologies. According to U.S. DOE, <u>MWTCF, ETCF</u>, and their stakeholders reduced energy consumption by over 19 million gallons of gasoline equivalent in 2017 alone (resulting in the avoidance of more than 90,000 tons of CO2). REAP to Fund Rural Energy Projects

The <u>Rural Energy for America Program (REAP) provides loan financing and grant funding</u> to agricultural producers and rural small businesses for renewable energy systems and energy efficiency improvements. This program helps improve American energy independence by both increasing the private sector supply of renewable energy and decreasing the demand for energy through energy efficiency improvements. Over time, these investments can also help lower energy costs for small businesses and agricultural producers. <u>Funding for Fiscal Year 2020 is available</u> in a variety of forms, each under its own application process and timeline. Grant applications are due by **March 31**. Applications for loan guarantees are accepted year-round.

Funds may be used for renewable energy systems, such as biomass (biodiesel and ethanol, anaerobic digesters, and solid fuels); geothermal for electric generation or direct use; hydropower below 30 MW; hydrogen; small and large wind generation; small and large solar generation; and ocean (tidal, current, thermal) generation. With regard to transportation, REAP funds may be used for solar-assisted electric vehicle charging stations. Funds may also be used for the purchase, installation, and construction of energy efficiency improvements, such as high efficiency heating, ventilation and air conditioning systems (HVAC); insulation; lighting; cooling or refrigeration units; doors and windows; electric, solar, or gravity pumps for sprinkler pivots; switching from a diesel to electric irrigation motor; and replacement of energyinefficient equipment. New Volkswagen Community Grant Program in Tennessee

Volkswagen, TVA, and the Conservation Fund recently created a community grant program to support local governments, tribal entities, or nonprofits working in eastern Tennessee to promote environmental education, local watershed quality, and outdoor recreation (which could include transportation and mobility projects such as trail development/enhancement and/or improved public access to outdoor recreation resources). Applicants are eligible to receive up to \$50,000, and applications are due by February 14. <u>Click here</u> to review the grant application.
