TREEDC Chairman/University of Tennessee at Martin Chancellor Dr. Keith Carver and TREEDC President/Dunlap Mayor Dwain Land have officially launched our 2024 membership campaign. The TREEDC board has kept the 2024 membership dues levels unchanged from prior years. Memberships help pay for expenses related to TREEDC's outreach, educational and project facilitation for our member local governments. This past year TREEDC celebrated its 15th anniversary of TREEDC's mission to connect economic development with clean energy across Tennessee.

TEMA's Budget Requests

TEMA has presented crucial budget requests that stand to significantly enhance our state's disaster preparedness and response capabilities. These requests include funding for the implementation of a Mesonet (Statewide Weather Station System) and expansion of the flood predictor tool program. These technological advancements promise to provide real-time, county-by-county weather data and improve our ability to mitigate, respond to, and recover from natural disasters. We're excited to support TEMA in both requests and encourage you to reach out to your representatives to let them know that Tennessee needs to invest in resilience tools.

Resilient Tennessee Revolving Loan Fund Act

We are thrilled to acknowledge the sponsorship of the Resilient Tennessee Revolving Loan Fund Act by Representative William Lamberth. This act, a key component of our shared resilience strategy, aims to create a revolving loan fund to support local communities impacted by disasters. Over the decades, energy efficiency has transformed the way we use energy and has helped build a cleaner economy that is more secure, more affordable, and more productive. After several years of slowed progress, recent federal funding provides the opportunity for states, local governments, businesses, and households to further investments in energy efficiency. Given the accelerating urgency of climate change and the race to improve U.S. productivity and competitiveness in a quickly evolving international market, we need to fully capitalize on the expansive, diverse, affordable, and innovative energy efficiency toolkit.

Using 59 indicators, the <u>Energy Efficiency Impact Report</u> tracks progress in a variety of sectors, including utilities, buildings, industry, and transportation and examines how policy and other tools are used to incentivize energy efficiency.

Renewable energy expanded more than 50 percent last year compared to 2022, potentially putting the international goal of tripling capacity by 2030 in sight, according to the International Energy Agency (IEA). State and Local Planning for Energy (SLOPE) Platform

The <u>State and Local Planning for Energy (SLOPE) Platform</u> is a collaboration between U.S. DOE and the National Renewable Energy Laboratory (NREL) designed to support data-driven state and local energy planning by delivering modeled energy data at state and local jurisdictional levels. Users can explore energy data potential and projections to better understand opportunities and options in energy planning. The platform includes equity filters to help communities prioritize equitable and inclusive clean energy planning and investments. SLOPE includes two distinct tools to support jurisdictions' planning needs: a <u>Scenario Planner</u> to compare scenarios for the future of energy, costs, and emissions for counties and states, and a <u>Data Viewer</u> to explore city, county, and state data on renewables, efficiency, and transportation.

Appalachian Carbon Forum

The <u>2024 Appalachian Carbon Forum</u>, hosted by the University of Kentucky and Oak Ridge National Lab (ORNL), will take place **March 7-8** in Lexington, KY. The two-day forum brings together a diverse range of thought leaders and innovators to identify and develop energy solutions for the Appalachian region.

The forum will feature discussions on the representative needs, challenges, and opportunities unique to the area with participants from local communities, private industry, national laboratories, academia, and government located along the Appalachian Mountain range. Sessions include topics ranging from clean energy solutions to emissions reduction and meeting power demands while working towards net-zero targets.


The Governor's Environmental Stewardship Awards include ten categories:
